### Introduction

Non-law graduates wishing to become barristers or solicitors must take the Graduate Diploma in Law (GDL) conversion course, sometimes referred to as the 'Common Professional Examination' (CPE). The GDL does not aim to cover everything contained in a three-year law degree in one year, but seeks to develop knowledge of the core areas of law and the skills of legal analysis and research that are essential to succeed on the professional courses and in the early years of practice. Once you have completed this course, you can go on to study the LPC (for intending solicitors) or the Bar Professional Training Course (for intending barristers).

### Course structure

There are seven core subjects that all conversion courses are required to cover as required by the Joint Academic Stage Board. These are:

- Contract Law
- Law of Tort
- Public Law
- Law of the European Union
- Equity and Trusts
- Land Law
- Criminal Law

All GDL students are also required to study 'another area of law'. At Westminster you fulfil this requirement by writing a 4,000 word dissertation on a different

The University year starts with a two week induction course which introduces you to the University campus structure, tutors, fellow students and facilities.
You are introduced to the English Legal System, Legal Research Methods and other essential skills which link previous education and the law.

### Legal skills

You can take part in a variety of legal skills' training events and competitions on the GDL course. Optional mooting, client interviewing and negotiating skills programmes are timetabled into the GDL programme with staff led classes and teaching materials provided. A moot is a contest in which opposing pairs of students act as counsel to argue a point of law before a 'judge'

There are Westminster Law School competitions in mooting, interviewing, negotiating and mediating skills with the winners representing the Westminster Law School in national competitions. In Law School in national competitions. In 2011 two students from the GDL and LLB Commercial Law course were successful in winning the National Negotiation Competition. Also in 2011 two LPC students were runners up in a national mediation competition. GDL students represented the Law School in international mediation competitions in Chicago (2008) and Liverpool (2009) and an international negotiation competition in London (2008).

Robson, is the chair of the National Client Interviewing Competition and a director of the National Negotiation Competition. He is also involved in organising international competitions and training students around the world in interviewing and negotiating skills.

### Assessment

You are required to pass an exam in the English Legal System (ELS) at the end of the induction course. Written examinations are taken in each of the seven foundation subjects in May. You are also required to pass three written assignments and a project during the academic year. Regular informal assessments, written and oral feedback from tutors are given to help you keep on track with your learning timetable prior to preparation for final exams.

Entry requirements
Minimum of a Lower Second Class Honours in a non-law degree or equivalent postgraduate degree.

## FREQUENTLY ASKED QUESTIONS





### Am I eligible to study the GDL course?

To be eligible to attend a GDL course, you must

 hold a minimum of a Lower Second Class Honours degree awarded by a UK university (there is normally no restriction on the subject matter of your degree)

You should also have a good standard of written and spoken English (IELTS 6.5 or to EFL equivalent).

### Why take the GDL if you already have a degree?

Taking the GDL after studying a non-law degree is often welcomed by many law firms and barristers' chambers because of the additional experience that can be brought to the legal profession.

How do I apply?
To apply for a place on a full-time GDL course, you should make an application through the Central Applications Board: lawcabs.ac.uk
Applications for part-time courses should be made through UKPASS www.ukpass.ac.uk also available on the University of Westminster law web pages.

How long is the qualification valid?

A GDL will remain valid for a period of seven years. It will then be considered 'stale' for the purpose of qualifying as a solicitor or barrister.

If you accept an offer on the full-time GDL course you are required to pay a holding deposit of £200 and £100 on the parttime GDL course. This is deducted from your final tuition fees.

Our fees are highly competitive with other providers. Half the fees are required to be paid at enrolment and the remainder by a stated instalment date. Fees normally increase slightly with inflation each year.

### LEGAL **PRACTICE** COURSE (LPC)

### Introduction

The LPC is the compulsory vocational course for intending solicitors prior to starting a training contract. The LPC is divided into two stages and these can be taken together or separately. We run a full-time day and part-time evening LPC.

With places limited to 120 students (full-time) and 64 students (part-time), the hallmark of our approach is small interactive group work, which allows us to give you individual guidance. Teaching sessions are set within a balanced timetable and are designed to replicate the tasks undertaken in practice.

### Course aims

Course aims
The LPC forms a bridge between a law degree or GDL and becoming a solicitor (normally via a training contract). Introducing you to the substantive law and legal procedure required by a trainee solicitor, our course aims to provide training in the practical skills that you will need to succeed in practice. A professionally qualified teaching team delivers the LPC using high quality teaching materials. Our aim is to guide you through the process required to become a solicitor. process required to become a solicitor.

The skills gained through the LPC will enable you to embark on relevant training contracts with high profile employers.



### LEGAL PRACTICE COURSE (LPC) **REQUIREMENTS**

You must normally have satisfied the following Solicitors Regulation Authority (SRA) requirements prior to commencing

- passed the academic stage of training by completing a qualifying law degree
- GDL (or equivalent qualification), and

With effect from 1 July 2014, the SRA no longer issues students enrolling on the LPC with the Certificates of Completion of Academic Studies or of Student Membership of the SRA. While some students may already be in receipt of such certification from the SRA, if you are not in possession of the SRA certification, it is particularly important that you take steps to satisfy yourself that your degree/GDL is indeed a Qualifying Law Degree (QLD) for the purpose of the LPC before you start on the course

If you accept an offer on the LPC you are required to pay a holding deposit to secure a place.

The SRA registration fee of £80 needs to be paid directly to the SRA on registration as a student member. You must contact the SRA directly to request an application pack for student membership.

Our fees are highly competitive with other providers. All University of Westminster LLB and GDL graduates may be eligible to receive a discount from their LPC fees. Please contact us for details on the current discounts being offered.

University of Westminster students who study the LPC part-time will receive 50 per cent of the discount in Year 1 and 50 per cent in Year 2.

Tuition fees are inclusive of all course materials and books.

The LPC Foundation Week
Both the full-time and part-time courses begin with an intensive foundation course introducing the core and pervasive areas. Part-time students must attend this first initial week on a full-time basis and should make necessary arrangements with their employer.

### **LPC** assessments

LPC assessments take place during and at the end of each subject. You are timetabled to allow sufficient revision and preparation time for examinations and assessments.

### **LPC** electives

You take three elective subjects. Full-time students start their electives in March. Part-time students start their first elective in April of Year 1 with the remaining two taken in Year 2.

### **Online Learning**

You will be issued with a username and email account which allows access to materials both at the University and elsewhere. You benefit from improved options for communication with individuals and other groups of students with use of a wide range of support options. Computer Assisted Learning (CAL) is used as part of the teaching and learning strategy of the LPC through the medium of the University's online learning tool, Blackboard.

In addition to our unique range of electives you have the option of the following:

### **Immigration Accreditation Scheme**

The Legal Services Commission (LSC) requires all advisers (including solicitors) who conduct publicly funded immigration and asylum work to be accredited under its Immigration and Asylum Accreditation Scheme. If you opt for our Immigration Law Elective you have the opportunity to seek exemption from Level 1 Accreditation requirements.

### Student Law Clinic

Both GDL and LPC students have the opportunity to participate in our Student Law Clinic.

There are a number of projects relating to Housing, Family or Property. The Student Law Clinic is a unique opportunity for you to participate in real client legal work. You will benefit from putting your skills into practice with real clients who will expect a service which matches that of a qualified lawyer.

### LLM Legal Practice

The University of Westminster offers you the option to join the LLM in Legal Practice upon completion of the LPC.
If you are interested in the course you will be assisted by LPC administrative staff in submitting an application in the summer of completing your LPC (subject to approval).

### **Mentoring Scheme**

LPC students can participate in our Mentoring Scheme. Each student will be allocated a practitioner mentor in a specialist area, who will offer advice and support. In some cases work shadowing/work experience placements are offered.

### Funding your GDL or LPC course

If you are thinking about qualifying as a solicitor or barrister, you need to be aware of how much it will cost to take the training that's necessary to complete the qualification process. Your calculation needs to include your living and travelling costs as well as the course fees.



### **Scholarships**

Some charitable trusts offer small amounts of finance for postgraduate courses.

The SRA offers a Bursary Scheme scholarship for GDL/LPĆ courses. The scheme is of interest to final year law students about to embark upon an LPC and to non-law students.
